ORDER

As per G.O. Read as first paper above, in exercise of the powers conferred under sub-section (4) of section 24 of the Right to Information Act, 2005 (Central Act 22 of 2005), Government had specified that the said Act shall not apply to certain Intelligence and Security Organisations established by the State Government, subject to the provisions contained in the proviso to that sub-sections. Now, vide Office Memorandum read as second paper, the Government of India have pointed out that the sub-section (1) of Section 24 of the Right to Information Act, 2005 do not exempt these organisations from the purview of the Act in respect of the information pertaining to the allegations of corruption and human rights violations. Thus, the citizens have a right, though limited, to seek information from these organisations. Therefore, it is necessary that these organisations too designate State Public Information Officers to deal with the applications under Right to Information Act. In this circumstances the Intelligence and Security Organisations mentioned in the G.O. Read as First paper above are ordered to designate and publish State Public Information Officers and first Appellate Officers for receiving and disposing the Applications and Appeals under

Right to Information Act in respect of the information pertaining to the allegations of corruptions and human rights violations.


